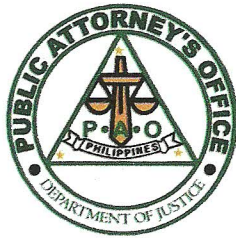
The period of maintenance and service to be provided by your company is from January 2, 2012 to December 31, 2012 subject to the other provision stipulated in the Contract.

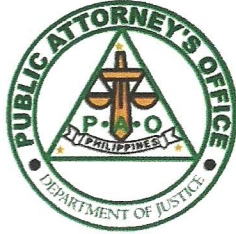
