RESOLUTION

RECOMMENDING THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF VARIOUS OFFICE FURNITURE AS SPECIFIED UNDER PURCHASE REQUEST NO. 966-08-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CENTRAL OFFICE AND DISTRICT OFFICES THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, after complying with the required posting¹ of the Request for Quotation (RFQ) for the subject procurement in accordance with the procedure set forth for SVP under the abovementioned provisions of RA 9184, three suppliers responded and submitted their detailed quotations;

WHEREAS, after conducting a comparative evaluation of their submitted quotations this committee evaluated² that the quotation submitted by IKF Home Furnishing and Office Furniture (IKF) appears to have the lowest calculated and responsive quotation while the other two submitted quotations from Ban Bee Commercial Co., Inc (Ban Bee) and See Manufacturing Contractor (SMC) were both found to be incomplete and unresponsive;

WHEREAS, considering the foregoing, BAC Member Atty. Demiteer Huerta moved to disqualify the submitted quotations of *Ban Bee* and *SMC* and award the procurement of the subject office furniture to *IKF* for being the lowest calculated and responsive quotation, subject to post-qualification under Section 39 of RA 9184, duly seconded by BAC Member Atty. Revelyn Ramos-Dacpano;


