RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF TWENTY FOUR (24) UNITS OF BIOMETRIC TIME RECORDER AS SPECIFIED UNDER PURCHASE REQUEST NO. 811-07-2018 TO ACXESSPOINT I.T. SOLUTIONS, INC. (ACXESSPOINT) FOR THE USE OF PUBLIC ATTORNEY'S OFFICE DISTRICT OFFICES THRU PAO-SUPPLY SECTION, ADMINISTRATIVE SERVICE THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, after complying with the required posting¹ of the Request for Quotation (RFQ) for the subject procurement in accordance with the procedure set forth for SVP under the abovementioned provisions of RA 9184, five suppliers responded and submitted their detailed quotations;

WHEREAS, after conducting a comparative evaluation of their submitted quotations this committee evaluated² that the quotation submitted by Acxesspoint appears to have the lowest calculated and responsive quotation;

WHEREAS, considering that Acxesspoint provided the lowest calculated and responsive quotation, BAC Member Atty. Demiteer Huerta moved to award the procurement of the subject biometric time recorders to Acxesspoint, subject to post-qualification and posting of performance security under Section 39 of RA 9184, thereafter BAC Member Atty. Mariel Baja moved to second the motion;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to recommend to the Head of Procuring Entity to AWARD THE CONTRACT FOR THE PROCUREMENT OF TWENTY FOUR (24) UNITS OF BIOMETRIC TIME RECORDER TO ACXESSPOINT I.T. SOLUTIONS,**
