RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO TATAK MANILA (TATAK) FOR THE PROCUREMENT OF FOUR HUNDRED TEN (410) PIECES OF WHITE COTTON T-SHIRTS AS SPECIFIED UNDER PURCHASE REQUEST NO. 926-08-2018 FOR THE USE OF PUBLIC ATTORNEY'S HUMAN RESOURCE MANAGEMENT DEVELOPMENT DIVISION (HRMDD), ADMINISTRATIVE SERVICE, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, three suppliers responded and submitted their detailed quotations on the Request for Quotation (RFQ) for the subject procurement in accordance with the procedure set forth for SVP under the abovementioned provisions of RA 9184;

WHEREAS, after conducting a comparative evaluation of their submitted quotations this committee evaluated¹ that the quotation submitted by Tatak Manila (*Tatak*) appears to have the lowest calculated and responsive quotation;

WHEREAS, considering that *Tatak* provided the lowest calculated and responsive quotation, BAC Member Atty. Demiteer Huerta moved to award the procurement of the subject T-Shirts to *Tatak*, subject to post-qualification, duly seconded by BAC Member Atty. Mariel Baja;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to RECOMMEND TO THE HEAD OF THE PROCURING ENTITY TO AWARD TO TATAK MANILA (TATAK) THE CONTRACT FOR THE PROCUREMENT OF FOUR HUNDRED TEN (410) PIECES OF WHITE COTTON**
