RESOLUTION

RECOMMENDING THE AWARD OF CONTRACT TO JOVENETTE FOR THE PROCUREMENT OF MOTOR COMPRESSOR AS SPECIFIED UNDER PURCHASE REQUEST NO. 936-08-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-LEGAL RESEARCH SERVICE, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, after complying with the required posting¹ of the Request for Quotation (RFQ) for the subject procurement in accordance with the procedure set forth for SVP under the abovementioned provisions of RA 9184, two suppliers responded and submitted their detailed quotations;

WHEREAS, after conducting a comparative evaluation of their submitted quotations, this committee evaluated² that the quotation submitted by JOVENETTE is found to be responsive and appears to be the lowest quotation compared to the other submitted quotation;

WHEREAS, considering the foregoing, BAC Member Atty. Demiteer Huerta moved to award the contract of procurement to JOVENETTE for having the lowest calculated and responsive quotation, subject to post-qualification under Section 39 of RA 9184, duly seconded by BAC Member Atty. Mariel Baja;
