RESOLUTION

DECLARING THE ABANDONMENT AND CANCELLATION OF THE PROCUREMENT OF REPLACEMENT TIRES FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CENTRAL OFFICE, AS SPECIFIED UNDER PURCHASE REQUEST NO. 1178-09-2018, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, after the issuance and posting² of a Request for Quotation for the subject procurement, it has come to the attention of this committee that the purchase request of for the subject procurement was cancelled³ by the head of the General Services Section, Engr. Cosmelo Diaz;

WHEREAS, considering the cancellation of the purchase request for the subject procurement, this committee through BAC Member Atty. Rigel A. Salvador moved to declare the subject procurement abandoned and cancelled there being no need to pursue the previously resolved procurement of replacement tires, duly seconded by BAC Member Atty. Jerome Feria;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to DECLARE THE ABANDONMENT AND CANCELLATION OF THE PROCUREMENT OF REPLACEMENT TIRES FOR PAO**


