RESOLUTION

RECOMMENDING THE PROCUREMENT OF CONTINUOUS FORM, AS SPECIFIED IN PURCHASE REQUEST NO. 965-08-18 THROUGH SHOPPING UNDER SECTION 52.1b IN RELATION TO ANNEX "H," NO. V, SUBSECTION (C)1-b OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184 FOR THE USE OF THE PUBLIC ATTORNEY'S OFFICE – CASH SECTION, ADMINISTRATIVE SERVICE

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee previously resolved¹ to direct the Technical Working Group (TWG) to conduct a mandatory review of the terms, conditions, and specifications of the subject procurement previously under purchase request no. 833-07-18;

WHEREAS, after the conduct of the said mandatory review, a new purchase request containing the revised terms and specifications of the subject procurement was submitted to this committee under purchase request no. 965-08-2018;

WHEREAS, there is an approved budget for the contract of the revised procurement of continuous form under purchase request no. 965-08-2018 with a total amount of Fifty Seven Thousand Eight Hundred Pesos (P57,800.00)².

WHEREAS, considering that the current need of the Office for the item is necessary for the discharge its daily mandate;

WHEREAS, considering that the pursuit of a competitive bidding relative to the procurement of the same shall likely be concluded only after the lapse of one hundred twenty (120) days, which period, may no longer be responsive to the immediate need of the Office;

WHEREAS, the subject of procurement is considered an ordinary office supply not available in the DBM-PS³ and the total amount of the subject procurement does not exceed One Million Pesos (P1,000,000.00), BAC Member Atty. Jerome Feria move
