### **RESOLUTION**

**DISQUALIFYING THE PARTICIPATION AND QUOTATION OF RER CONSTRUCTION SUPPLIES (R.E.R.) IN THE PROCUREMENT OF BUILDING MAINTENANCE MATERIALS AS SPECIFIED UNDER PURCHASE REQUEST NO. 660-06-2018.**

**WHEREAS**, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

**WHEREAS**, R.E.R. was previously notified of the qualification<sup>1</sup> of their submitted quotation and was required to submit a mayor's/business permit to prove legality of the operation of their business in accordance with GPPB Resolution No. 21-2017. 30 May 2017;

**WHEREAS**, despite the assurance of R.E.R. thru its representative Juana Bacalso that it will submit said document on a scheduled date for its pick up, RER suddenly refused to provide the said document after the designated PAO-employee personally appeared before its establishment and noticed the lack of posting of the said mayor's/business permit in its establishment;

**WHEREAS**, considering the failure and unjust refusal and inability of R.E.R. to provide to this committee its mayor/business permit, BAC Member Atty. Demiteer Huerta moved to disqualify the participation and quotation of R.E.R. for the subject procurement, duly seconded by BAC Member Atty. Mariel Baja;

**NOW THEREFORE, WE**, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to DECLARE THE DISQUALIFICATION R.E.R. CONSTRUCTION SUPPLIES (R.E.R.) IN ITS PARTICIPATION AND QUOTATION FOR THE PROCUREMENT OF BUILDING MAINTENANCE MATERIALS AS SPECIFIED UNDER PURCHASE REQUEST NO. 660-06-2018.**
