FURTHER EXTENDING THE DATE OF THE LAST DAY OF SUBMISSION OF QUOTATION TO 28 AUGUST 2018 FOR THE PROCUREMENT OF THE SUPPLY AND INSTALLATION OF FLOOR MOUNTED AIR-CONDITIONING UNIT AS SPECIFIED UNDER PURCHASE REQUEST NO. 832-07-2018 FOR THE USE OF PUBLIC ATTORNEY'S OFFICE-CALOOCAN CITY DISTRICT OFFICE, THROUGH SMALL VALUE PROCUREMENT (SVP) UNDER SECTION 53.9 IN RELATION TO ANNEX "H," NO. V, SUBSECTION (D)8-a OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT NO. (RA) 9184

WHEREAS, the Public Attorney's Office (PAO) is committed to adhere to the State's Policy of securing and maintaining the trust and confidence of every Filipino, by upholding transparency, good governance and anti-corruption measures;

WHEREAS, this committee did not receive any quotations for the subject procurement until the previous scheduled deadline of submission of quotation last 17 August 2018;

WHEREAS, it was relayed by the PAO-Caloocan District Office to this committee that inspection of their facility was already conducted and is now awaiting processing of quotation from suppliers;

WHEREAS, considering that no quotation was received for the subject procurement, BAC Member Atty. Jerome Feria moved to extend anew the deadline for the submission of quotation for the subject procurement to 28 August 2018 to give the PAO-Supply section, in coordination with the Technical Working Group of this Committee, reasonable time to obtain proper quotations from qualified suppliers, duly seconded by BAC Member Atty. Mariel Baja;

NOW THEREFORE, WE, the Members of the PAO Bids and Awards Committee (PBAC), by virtue of the powers vested on Us by Law, after duly considering the recommendations of the Technical Working Group (TWG), and all members here present, **hereby resolve to EXTEND ANEW THE DEADLINE FOR THE SUBMISSION OF QUOTATION TO 28 AUGUST 2018 FOR THE PROCUREMENT OF THE SUPPLY AND INSTALLATION OF A FLOOR MOUNTED AIR-CONDITIONING UNIT as described in PURCHASE REQUEST NO. 832-07-2018, for the use of the Public Attorney's Office – Caloocan City District Office.**
